## CONSIGNMENT AGREEMENT

Trailer Country LLC and the Owner agree that the sale price of the consigned trailer will be \$\_\_\_\_\_. At the time of the sale, Trailer Country LLC will receive 10% of the sale price or a minimum of \$500. In addition to the commission, Owner agrees to pay TCLLC a \$129 inspection and cleaning fee. That fee is due at time of consignment. Owner understands that under Virginia Law the vehicle must be inspected by a licensed Virginia State Inspection station after consignment and prior to sale. Owner agrees to pay any costs associated with bringing the vehicle into compliance with inspection standards whether or not the vehicle is sold through TCLLC. As part of our inspection and cleaning, we will check all wheels, brakes, lights and batteries. You will be notified of any charges in excess of \$100 that are required to bring the trailer to our standards.

Trailer should be free of all tack, feed, bedding and manure.

You will be required to leave your trailer a minimum of 6 weeks. We require a copy of the registration, consignment agreement and the signed title.

Trailer Country LLC is NOT responsible for loss or damage to said trailer or any articles left in said trailer in case of fire, theft, accidents, vandalism or any other cause beyond our control.

Settlements will be paid by check within 14 days of the sale of the trailer as long as all of the seller's documents have been signed and submitted. A copy of the bill of sale and all associated documents will be included.

Trailers will not be listed for sale until all cleaning and inspections are completed. Please keep in mind that we will work diligently to get your trailer online within 7 business days, but our prior workload sometimes prohibits that.
